This past year marked an exciting new chapter for the Cancer Research Institute (CRI)—and for me personally, as I joined the organization in August 2024. It has been an honor to lead an institute that is transforming cancer care through the power of immunotherapy. Guided by our strategic focus on *People, Biology, and Data*, we are shaping a future where every individual with cancer has access to groundbreaking treatments tailored to their unique needs. This vision fuels everything we do, from funding trailblazing research to mentoring the next generation of scientific pioneers.

In fiscal year 2024, CRI invested \$22.8M in cutting-edge research across seven countries, awarding 64 new grants to drive discovery and innovation. Our support spanned critical areas—including clinical trials, postdoctoral fellowships, and technological advancements—reinforcing our commitment to accelerating the development of lifesaving immunotherapies. This investment is making a tangible impact: today, immunotherapy is available for 29 types of cancer, offering hope to approximately 9M newly diagnosed patients worldwide.

Through a steadfast commitment to financial stewardship, with 83% of expenditures directed toward research and patient education, CRI ensures that every dollar advances our mission. As we

look ahead, we remain dedicated to pushing the boundaries of science, expanding access to immunotherapy, and ultimately achieving a world immune to cancer.

# 5 New CRI Lloyd J. Old STARs

The CRI Lloyd J. Old STAR (Scientists TAking Risks) Program designates long-term funding to mid-career scientists, giving them the flexibility to pursue high-risk, high-reward research projects with the potential to make groundbreaking discoveries and innovations in cancer immunotherapy. The CRI Lloyd J. Old STAR Award is not tied to a specific research project but,

rather, supports outstanding researchers based on the quality and promise of their overall work. Candidates selected for this award are expected to be the future leaders in the field of cancer immunotherapy, and this sustained funding will enable them to carry out transformational research. Each grant provides \$1.25M in funding over the course of five years.

## 32 Postdoctoral Fellowships in Three Separate Tracks

The CRI Irvington Postdoctoral Fellowship Program provides support for promising young scientists at prestigious universities and research institutions around the globe. These scientists are seeking training in fundamental immunology or cancer immunology and are rigorously selected by our Scientific Advisory Council.

The CRI Irvington Postdoctoral Fellowship to Promote Racial Diversity empowers young scientists from underrepresented groups who seek to undergo training in fundamental immunology and cancer immunology.


The CRI Immuno-Informatics Postdoctoral Fellowship is designated for scientists who wish to be trained in both quantitative and biological sciences. CRI is convinced that immunological research and data science can propel future immunotherapy breakthroughs, and funding young, promising scientists to master these disciplines is the path forward.

All newly awarded fellowships provide \$243,000 over three years to cover the fellow's salary plus an institutional allowance. CRI also provides funding to allow its fellows to attend the CRI-ENCI International Cancer Immunotherapy Conference and the annual CRI Bioinformatics Bootcamp.










#### **PROGRAM HIGHLIGHTS**



Andrea Schietinger, PhD (CRI Lloyd J. Old STAR at Memorial Sloan Kettering Cancer Center) is advancing our understanding of how tumor-specific T cells can be reprogrammed for better cancer therapies. Her research reveals that CD4 T cells play a key role in empowering CD8 T cells to eliminate tumors during adoptive T cell therapy. She discovered that tumor-specific CD4 and CD8 T cells must interact with antigen-presenting cells (APCs) to reprogram CD8 T cells, preventing dysfunction and enabling tumor eradication. This groundbreaking work opens new possibilities for enhancing immunotherapy in solid tumors by leveraging these critical cell interactions.


CRI-supported researchers at the Icahn School of Medicine at Mount Sinai—Nelson M. LaMarche, PhD (CRI-Bristol Myers Squibb Postdoctoral Fellow), Thomas Urban Marron, MD, PhD (CRI Clinical Innovator), and Miriam Merad, MD, PhD (CRI Scientific Advisory Council member)—have uncovered how cancer manipulates the immune system to fuel its own growth. Their research shows that tumors release signals activating IL-4 in the bone marrow, which reprograms immune cells to create a tumor-friendly environment. This discovery not only deepens our understanding of cancer's tactics but also identifies IL-4 as a promising target for new, more effective immunotherapies.



#### **PROGRAM HIGHLIGHTS**

Valsamo Anagnostou, MD, PhD (CRI-Torrey Coast Foundation GEMINI CLIP Investigator at Johns Hopkins) has revolutionized gastroesophageal cancer care. Her recent <u>Nature Medicine</u> study uses liquid biopsy (ctDNA testing) to predict which patients benefit most from immune checkpoint inhibitors (ICIs) and explores the effectiveness of neoadjuvant ICI therapy. This breakthrough offers a new way to personalize and monitor treatment, bringing fresh hope to patients and transforming how gastroesophageal cancer is managed.





Peng Jiang, PhD (CRI Technology Impact Award Investigator at the National Cancer Institute) is combining artificial intelligence (AI) and functional genomics to enhance T cell therapies for solid tumors. His project develops an AI model to predict factors that boost T cell antitumor activity, alongside CRISPR screens to identify key genes that improve T cell efficacy. This research aims to uncover new gene targets, create patient biomarkers, and provide an AI framework to advance cell therapy in solid tumors, offering promising new strategies for more effective treatments.

# CRI Collaborated with Oncology Experts to Identify Gaps in Advanced NSCLC Research

CRI, in partnership with Regeneron Pharmaceuticals, commissioned an online survey of 250 U.S. oncologists through The Harris Poll to explore treatment options for advanced non-small cell lung cancer (NSCLC). The survey revealed that 96% of oncologists agreed on the importance of having multiple treatment options for patients, and 71% expressed interest in additional research focused on new combination therapies involving immunotherapy. This collaboration highlighted the critical need for further research to overcome treatment resistance and expand access to clinical trials, emphasizing the need for innovative approaches in NSCLC treatment to improve patient outcomes. **>> READ MORE HERE**

#### PATIENT ENGAGEMENT AND OUTREACH




In FY2024, CRI expanded its outreach and patient engagement efforts with a series of impactful events and educational initiatives. The 2023/24 CRI Patient Immunotherapy Summit, moderated by Emmy Award-winning journalist Tamron Hall, provided a deep dive into the latest cancer immunotherapy advancements, featuring key experts such as Dr. Jedd Wolchok, Dr. Elizabeth M. Jaffee, Dr. Kunle Odunsi, Dr. Sarah Sammons, and Dr. Thomas Urban Marron. The summit brought together patients, caregivers, and clinicians to discuss the future of immunotherapy for various cancer types, with key sessions on pancreatic, ovarian, breast, and lung cancers.

Additionally, CRI launched its Spanish-language Immunotherapy Patient Summit in early 2024, hosted by television host and entrepreneur Ana Patricia Gámez, to reach and educate the Spanish-speaking community on cutting-edge research and treatment options.






CRI also held a series of four patient education webinars in FY2024, which explored a range of topics such as the future of cancer immunotherapy, CRISPR advancements, lung cancer treatments, and cancer vaccines. These webinars featured distinguished experts such as Dr. Nina Bharadwaj, Dr. Alexander Marson, Dr. Thomas Urban Marron, and Dr. Vinod Balachandran. Furthermore, CRI facilitated a focus group discussion on cancer survivorship, and an encore of the Patient Summit was featured during June's Cancer Immunotherapy Month, furthering CRI's commitment to providing patients with the knowledge and resources to navigate cancer treatment options and improve their quality of life.
